9. (i) No drug shall be sold unless such drug is purchased from a duly licensed dealer or a duly licensed manufacturer. (ii) No sale of any drug shall be made for purposes of resale to a person not holding the requisite licence to sell, stock or exhibit for sale or distribute the drug.

10. This permission shall be endorsed on the licence by the Licensing Authority in respect of which such permission given. This permission shall be valid for sale, or exhibit for sale, or distribute for sale, or exhibit for sale, of the categories of drugs listed in schedules C and C(1) [excluding those specified in this licence, he should apply to the Licensing Authority for necessary permission. This licence will be deemed to extend to the categories of drugs in respect of which such permission given.
